The proving of the natural gasfield in South Australia has been a most important step in the State's programme of development and plans now are well advanced for bringing this economical and efficient fuel to Adelaide.

Members of the Natural Gas
Pipelines Authority of South
Australia were appointed on the
20th April this year and since have
met on 12 occasions.

This week, I received a most satisfactory and encouraging report from the Authority which contains some good news which I would like to pass on to you.

Firstly, the date scheduled for completion of the pipeline has been determined as September, 1969.

This, by a happy coincidence, is the earliest date at which the Electricity Trust will be able to use natural gas. As the construction is expected to commence next

September this means that the 480 mile long pipeline will take only twelve months to lay beneath the surface of the ground in a long trench at an average of 40 miles a month.

The second item of good

news is that the Authority has been

able to assure the Government that

the construction cost of the

project will be contained within

the original estimate of \$29 million

and, in fact there appear to be

good prospects of the cost being

below that figure.

Considerable progress has been made with the detailed arrangements involved in establishing the right-of-way which will be needed for the pipeline installation.

It is very pleasing to report the great degree of co-operation which has been extended to the Natural Gas Pipeline Authority by local government bodies and land owners.

Alberta Gas Trunk Line Company of Canada also has undertaken to supply any technical data and to train staff for the Authority if required. As a result, the South Australian natural gas pipeline will be the most modern and efficient in the world.

And, finally, a fourth piece of good news concerns the financing of the pipeline. The Pipeline Authority has held discussions with Australian Savings Banks and Life Societies concerning the capital cost of \$29 million. These financial institutions unhesitatingly have assured the Authority of their interest in the South Australian natural gas pipeline project and have undertaken collectively to subscribe no less than \$20 million to assist with the financing of the undertaking.
